Full-Time Equivalent Research Experience is measured from the date when a researcher obtained the degree entitling him or her to embark on a doctorate, either in the country in which the degree was obtained or in the country in which the researcher is recruited, even if a doctorate was never started or envisaged. Part-time research experience will be counted pro-rata.







□ I declare that at the time of recruitment, I have NOT resided or carried out my main activity (work, studies, etc.) in the Netherlands or the country of the secondment partner for more than 12 months <u>in either country</u> in the three years immediately before 26 August 2019. Time spent as part of a procedure for obtaining refugee status under the Geneva Convention, compulsory national service and/or short stays such as holidays are not taken into account.
